Terms and Conditions

1. Upon acceptance as a contestant in the Miss Asian Oregon Pageant I have read and agreed to the following.
2. **Definition.** The following terms are defined as follows:
 - a. **Contestant.** Contestants are all women whose applications have been accepted by the contestant committee.
 - b. **Court.** The court comprises of all titles holders granted titles the night of the pageant. The title holders include, but are not limited to Miss Asian Oregon Queen, Miss Asian Oregon First Princess, Miss Asian Oregon Second Princess, Miss Congeniality, Miss Scholastic Achievement, Miss Talent.
 - c. **Tenure.** Tenure consists of the time period I am a part of the contestant pool or a part of the Court. My tenure with the Miss Asian Oregon program may cease if I am requested to withdraw my candidacy or if my candidacy has been involuntarily withdrawn.
 - d. **Involuntary withdrawal.** Involuntary withdrawal may occur when a material breach of the agreement occurs and at the request of Michelle Ing or Byron Wong.
3. I permit Miss Asian Oregon, LLC and its licensed affiliates to use my image from the contestant stage until the end of the court in all promotional materials. This license is granted freely, indefinitely and in perpetuity.
4. I am genetically female.
5. I am not married.
6. I am not and have never been pregnant.
7. I agree not to initiate a romantic relationship between myself and any volunteer, sponsor or judge with the Miss Asian Oregon program during my tenure as a contestant or member of the court. Should a relationship exist or transpire during my tenure as a contestant or as a part of the court, I will disclose that information to Michelle Ing or Byron Wong. I agree that I may or may not be requested to relinquish my status as contestant or my title. Upon completion of my tenure with the Miss Asian Oregon Program, I understand I am free to pursue or engage in relationships as I see fit.
8. I agree to maintain the utmost decorum as a contestant of Miss Asian Oregon. Should I be selected a member of the court, I will maintain the decorum during my tenure as a representative of Miss Asian Oregon. As a contestant and/or member of the court, I agree that I:

- a. will not smoke or partake in any form any tobacco products;
 - b. will not partake of any illicit drugs;
 - c. will not drink alcoholic beverages during Miss Asian Oregon functions;
 - d. will not drink to levels of intoxication/inebriation in my personal life.
9. I agree that I will not speak ill or present in a bad light of any volunteer, judge, promoter or sponsor of the Miss Asian Oregon pageant.
10. I agree I will not disclose and will maintain confidences of the Miss Asian Oregon pageant.
11. All statements made in my application are true and correct to the best of my ability.
12. **Severability.** If there are any sections or subsections in the terms and conditions which are deemed invalid, it may be severed, so as not to invalidate the entire agreement.
13. **Grievances.** Any grievances regarding this agreement or the Miss Asian Oregon Program should be submitted in writing to Michelle Ing and Byron Wong within twenty-one (21) days of the occurrence. I agree that I will abide by the decisions of Michelle Ing and Byron Wong.
14. **Governing Law.** I agree that the Governing law shall be the laws of the State of Oregon.
15. **Arbitration.** Any dispute involving this agreement or any dispute between myself, heirs or assigns and Miss Asian Oregon, LLC or its affiliates will be submitted to a one panel arbitrator with the American Arbitration Association. Any arbitration between the parties will take place in Portland, Oregon.
